

### ZENITH FIBRES LIMITED Policy on Determination of Materiality of Events

#### 1. PREFACE:

The SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations) requires every Listed Company to frame a Policy on Materiality of Events and its Disclosure to Stock Exchanges under Regulation 4(2)(e) in Chapter II and Regulation 30(4). In terms of the said requirement, the Company - Zenith Fibres Limited formulates the Policy on Determination of Materiality of Events or Information and its Disclosure to Stock Exchanges on the following lines.

### 2. APPLICABILITY:

This policy shall be applicable to all the events in the Company, as and when they fall under the criteria enumerated in the policy.

### 3. CRITERIA FOR DETERMINATION OF MATERIALITY OF EVENTS / INFORMATION:

Materiality has to be determined on a case-to-case basis depending on specific facts and circumstances relating to the information/event. In order to determine whether a particular event/information is material in nature, the Company shall consider the criteria(s) mentioned below.

- 1. The omission of an event or information, which is likely to result in discontinuity or alteration of event or information already available publicly; or
- 2. The omission of an event or information is likely to result in significant market reaction if the said omission came to light at a later date; or
- 3. the omission of an event or information, whose value or the expected impact in terms of value, exceeds the lower of the following:
  - i, two percent of turnover, as per the last audited consolidated financial statements of the Company;
  - ii. two percent of net worth, as per the last audited consolidated financial statements of the Company, except in case the arithmetic value of the net worth is negative;
  - iii. five percent of the average of absolute value of profit or loss after tax, as per the last three audited consolidated financial statements of the Company;
- 4. In case where the criteria specified in sub-clauses (1), (2) and (3) are not applicable, an event/information may be treated as being material if in the opinion of the board of directors of Company, the event / information is considered material.

An illustrative list of events / information which shall be disclosed without application of materiality guidelines listed in this Policy is attached as **Annexure I.** 

An illustrative list of events / information which shall be disclosed to the stock exchanges on application of guidelines of materiality listed in this Policy is attached as **Annexure II.** 

Further, in terms of the Listing Regulations the Company shall also disclose the other events specified in **Annexure III.** 

The above list of events as enumerated in Annexure **I**, **II & III** shall deemed to have been updated/amended as and when the new additions / deletions made under the Listing regulations.

# 4. Guidance on occurrence of event / availability of information, Timing and Details of Disclosure:

- The timing of occurrence of an event and/or availability of information has to be decided on a case to case basis in term of the Listing Regulations.
- In case of natural calamities, disruptions etc. the events/information can be said to have occurred when the Company becomes aware of the information.
- In matters which would depend on the stage of discussion, negotiation or approval, the events/information can be said to have occurred upon receipt of approval by the Board of Directors or after receipt of approval of the Board of Directors and shareholders, as the case may be.
- the Company shall first disclose to the stock exchange(s) all events or information which are material in terms of the provisions of the Listing Regulations as soon as reasonably possible and in any case not later than the following:
- i. thirty minutes from the closure of the meeting of the board of directors in which the decision pertaining to the event or information has been taken;
- ii. twelve hours from the occurrence of the event or information, in case the event or information is emanating from within the Company;
- iii. twenty four hours from the occurrence of the event or information, in case the event or information is not emanating from within the Company.

# The specific timelines for disclosure of each of event in terms of regulation are specified in Annexures as under:

- a) Time line for events/information which shall be disclosed without any application of the guidelines for materiality **Refer Annexure I**
- b) Time line for events/information which shall be disclosed to the stock exchanges on application of guidelines of materiality listed **Refer Annexure II**
- c) Time line for Other Events/Information **Refer Annexure III**

# The Details of information to be given for event/ information in terms of the regulations are specified in Annexure as under:

- a) Details of Disclosure of events/information which shall be disclosed without any application of the guidelines for materiality **Refer Annexure IV (A)**
- b) Details of Disclosure of events/information which shall be disclosed to the stock exchanges on application of guidelines of materiality listed **Refer Annexure IV (B)**
- c) Details of Disclosure of other events/information **Refer Annexure IV (C)**

#### 5. IMPLEMENTATION:

To give effect to the requirements under the Listing Regulations, the Board has authorized the Team comprising of the Executive Chairman, Whole time Director Finance and Company Secretary of the Company to determine jointly and/or severally the materiality of an event/information. The heads of various departments and Senior Management Employees of the Company are under an obligation to forthwith notify in a specified format to the Executive Chairman and Whole time Director Finance and provide all relevant details with regard to any event/information which is likely to be construed as material under this Policy.

The Executive Chairman, Whole time Director Finance and Company Secretary and/or the person(s) authorized by the Board is authorized to ensure the compliance of disclosure / dissemination of such events / information to the stock exchange and website of the Company within the timeframe specified in the Listing Regulations, as amended from time to time.

### 6. AUTHORIZATION FOR DISCLOSURES:

The Board of Directors of the Company have nominated the following Key Managerial Personnel (KMPs) of the Company holding position of –

- 1. Executive Chairman
- 2. Whole time Director Finance
- 3. Company Secretary

to determine either jointly and/or severally, the materiality of an event or information and also authorized Executive Chairman, Whole time Director Finance and Company Secretary and /or the person(s) authorized by the Board of Directors / Company to ensure timely compliance of such events / information to the Stock Exchanges as required under Regulation 30(5) of the Listing Regulations, as amended from time to time. The Company shall frame Standard Operating Procedure in order to determine the materiality and timely compliance of the regulation and the Policy.

In case the amount involved in ongoing litigations or disputes with an opposing party become material ona cumulative basis, then the same shall also be required to be disclosed to the stock exchange(s).

### 8.1. At the time of becoming the party:

- a) brief details of litigation viz, name(s) of the opposing party, court/tribunal/agency where litigation is filed, brief details of dispute/litigation;
- b) expected financial implications, if any, due to compensation, penalty etc.;
- c) quantum of claims, if any;

### 8.2. Regularly till the litigation is concluded or dispute is resolved:

- a) the details of any change in the status and / or any development in relation to such proceedings;
- b) in the case of litigation against key management personnel or its promoter or ultimate person in control, regularly provide details of any change in the status and / or any development in relation to such proceedings;

c) in the event of settlement of the proceedings, details of such settlement including terms of the settlement, compensation/penalty paid (if any) and impact of such settlement on the financial position of the Company.

# 9. Frauds or defaults by employees of the Company which has or may have an impact on the Company:

### 9.1. At the time of unearthing of fraud or occurrence of the default/arrest:

- a) nature of fraud/default/arrest;
- b) estimated impact on the Company;
- c) time of occurrence;
- d) person(s) involved;
- e) estimated amount involved (if any);
- f) whether such fraud has been reported to appropriate authorities.

# 9.2. Subsequently intimate the stock exchange(s) further details regarding the fraud/default including:

- a) actual amount involved in the fraud /default (if any);
- b) actual impact of such fraud /default on the Company and its financials;
- c) corrective measures taken by the Company on account of such fraud/default.

### 10. Options to purchase securities (including any Share Based Employee Benefit (SBEB) Scheme) at the time of instituting the scheme and vesting or exercise of options:

- a) brief details of options granted;
- b) whether the scheme is in terms of SEBI (SBEB) Regulations, 2021 (if applicable);
- c) total number of shares covered by these options;
- d) pricing formula;
- e) options vested;
- f) time within which option may be exercised;
- g) options exercised;
- h) money realized by exercise of options;
- i) the total number of shares arising as a result of exercise of option;
- j) options lapsed;
- k) variation of terms of options;
- I) brief details of significant terms;
- m) subsequent changes or cancellation or exercise of such options;
- n) diluted earnings per share pursuant to issue of equity shares on exercise of options.

# 11. Giving of guarantees or indemnity or becoming a surety, by whatever name called, for any third party:

- a) name of party for which such guarantees or indemnity or surety was given;
- b) whether the promoter/ promoter group/ group companies have any interest in this transaction If yes, nature of interest and details thereof and whether the same is done at "arm's length";

- c) brief details of such guarantee or indemnity or becoming a surety viz, brief details of agreement entered (if any) including significant terms and conditions, including amount of guarantee;
- d) impact of such guarantees or indemnity or surety on Company.

The above details for giving of guarantees or indemnity or becoming a surety, by whatever name called, including comfort letter, side letter, etc., shall also be required to be disclosed in case the amount involved in terms of outstanding guarantees, indemnity or surety for a third party become material on a cumulative basis.

# **12.** Granting, withdrawal, surrender, cancellation or suspension of key licenses or regulatory approvals:

- a) name of the regulatory or licensing authority;
- b) brief details of the approval/license obtained/ withdrawn/ surrendered;
- c) impact/relevance of such approval/license to the Company;
- d) withdrawal/cancellation or suspension of license/approval by the regulatory or licensing authority, with reasons for such action, estimated impact (monetary or otherwise) on the Company and penalty, if any;
- e) period for which such approval/license is/was valid;
- f) Subsequently, the Company shall inform the stock exchange(s), the actual impact (monetary or otherwise) along with corrective actions taken by the Company pursuant to the withdrawal, cancellation or suspension of the key license/approval.

# **13.** Delay or default in the payment of fines, penalties, dues, etc. to any regulatory, statutory, enforcement or judicial authority:

- a) name of the authority;
- b) details of fines, penalties, dues, etc. including amount;
- c) due date of payment;
- d) reasons for delay or default in payment;
- e) impact on financial, operation or other activities of the Company, quantifiable in monetary terms to the extent possible.

In addition to the above, details of payment including date of payment and amount Paid shall be disclosed upon payment of the fines, penalties, dues, etc.

**C.** Details which a Company need to disclose In terms of Para C of Part A of Schedule III of LODR Regulations (refer Annexure III Serial No (1) viz, major development that is likely to affect business, e.g. emergence of new technologies, expiry of patents, any change of accounting policy that may have a significant impact on the accounts, etc. and brief details thereof and any other information which is exclusively known to the Company which may be necessary to enable the holders of securities of the Company to appraise its position and to avoid the establishment of a false market in such securities.
